Terms and Conditions of Use for Travel Related Web Site.

2. RELATIONSHIP

No joint venture, partnership, employment, agency or fiduciary relationship exists between you and Company as a result of your use of our travel services, including the Travel Site. Company is acting as an independent contractor.

3. USE OF THE TRAVEL SITE

You may only use the Travel Site to make legitimate reservations or purchases and shall not use the Travel Site for any other purposes, including making any speculative, false or fraudulent reservation or any reservation in anticipation of demand. You may not (a) use any "robot," "spider" or other automatic device, or a program, algorithm or methodology having similar processes or functionality, or any manual process to monitor or copy any of the web pages, data or content found on the Travel Site, (b) deep link to any portion of the Travel Site, without the prior written permission of Company, or (c) use the Travel Site in violation of, or to violate, any law, rule or regulation.

You hereby consent and submit to the personal jurisdiction of such courts for the purposes of litigating any such action. If any provision of these terms shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from these terms and shall not affect the validity and enforceability of any remaining provisions. This is the entire agreement between us relating to the subject matter herein and shall not be modified except in writing, signed by both parties.
